Thermal stability

Organic peroxides are thermally unstable substances, which may undergo self-accelerating decomposition. The lowest temperature at which self-accelerating decomposition of a substance in the original packaging may occur is the Self-Accelerating Decomposition Temperature (SADT). The SADT is determined on the basis of the Heat Accumulation Storage Test.

Method	The Heat Accumulation Storage Test is a recognized test method for the determination of the SADT of organic peroxides (see Recommendations on the Transport of Dangerous Goods, Manual of Tests and Criteria - United Nations, New York and Geneva).

Storage

Due to the relatively unstable nature of organic peroxides a loss of quality can be detected over a period of time. To minimize the loss of quality, Nouryon recommends a maximum storage temperature (Ts max.) for each organic peroxide product.

Note	When stored under these recommended storage conditions Cadox® D-50 RED will remain within the Nouryon specifications for a period of at least 3 months after delivery.

Packaging and transport

Cadox® D-50 RED is packed in non-returnable, 5 gallon polyethylene containers of 40 lb net weight. Both packaging and transport meet the international regulations. For the availability of other packed quantities contact your Nouryon representative. Cadox® D-50 RED is classified as Organic peroxide type D; liquid; Division 5. 2; UN 3105.

Safety and handling

Keep containers tightly closed. Store and handle Cadox® D-50 RED in a dry well-ventilated place away from sources of heat or ignition and direct sunlight. Never weigh out in the storage room.
