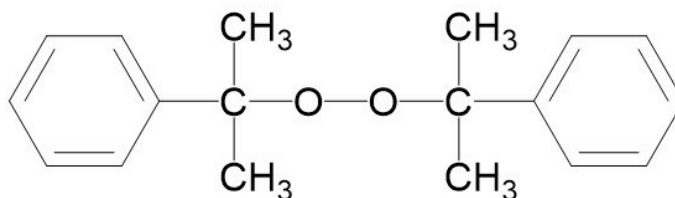


## Perkadox BC-40B-PD

### Applications

Perkadox® BC-40B-PD is a monofunctional peroxide which is used for the crosslinking of natural rubber and synthetic rubbers, as well as polyolefins. Rubber compounds containing Perkadox® BC-40B-PD have excellent scorch safety, and under certain conditions one step mixing is possible. Safe processing temperature: 130°C (rheometer ts2 > 20 min.). Typical crosslinking temperature: 170°C (rheometer t90 about 12 min.)

### Thermal stability

Organic peroxides are thermally unstable substances, which may undergo self-accelerating decomposition. The lowest temperature at which self-accelerating decomposition of a substance in the original packaging may occur is the Self-Accelerating Decomposition Temperature (SADT). The SADT is determined on the basis of the Heat Accumulation Storage Test.

SADT	80°C
Method	The Heat Accumulation Storage Test is a recognized test method for the determination of the SADT of organic peroxides (see Recommendations on the Transport of Dangerous Goods, Manual of Tests and Criteria - United Nations, New York and Geneva).

## Storage

Due to the relatively unstable nature of organic peroxides a loss of quality can be detected over a period of time. To minimize the loss of quality, Nouryon recommends a maximum storage temperature

Ts max.	30°C
Note	When stored under strictly recommended storage conditions, Perkadox® BC-40B-PD will remain within the Nouryon specifications for a period of at least 12 months after delivery.

## Packaging and transport

In North America Perkadox® BC-40B-PD is packed in non-returnable poly-lined cartons of 50 lb net weight. In other regions the standard packaging is a cardboard box for 20 kg peroxide formulation. Both packaging and transport meet the international regulations. For the availability of other packed quantities consult your Nouryon representative. Perkadox® BC-40B-PD is classified as Flammable solid, class 4. 1, UN 1325.

## Safety and handling

Keep containers tightly closed. Store and handle Perkadox® BC-40B-PD in a dry well-ventilated place away from sources of heat or ignition and direct sunlight. Never weigh out in the storage room. Avoid contact with reducing agents (e. g. amines), acids, alkalines and heavy metal compounds (e. g. accelerators, driers and metal soaps). Please refer to the Safety Data Sheet (SDS) for further information on the safe storage, use and handling of Perkadox® BC-40B-PD.
