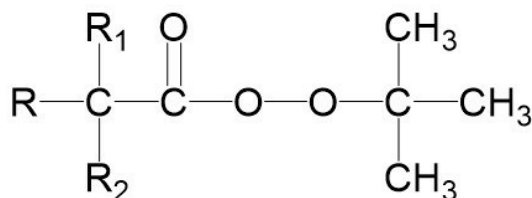

Applications

Polymerization of ethylene Trigonox® 23-C30 is an efficient initiator for the production of Low Density Polyethylene (LDPE). It is used both for tubular and autoclave processes. In most cases a combination with other peroxides is used to ensure a broad reactivity range.

Half-life data

The reactivity of an organic peroxide is usually given by its half-life ($t_{1/2}$) at various temperatures. For Trigonox® 23-C30 in chlorobenzene half-life at other temperatures can be calculated by using the equations and constants mentioned below:

0.1 hr	at 84°C
1 hr	at 64°C
10 hr	at 46°C

Thermal stability

Organic peroxides are thermally unstable substances, which may undergo self-accelerating decomposition. The lowest temperature at which self-accelerating decomposition of a substance in the original packaging may occur is the Self-Accelerating Decomposition Temperature (SADT). The SADT is determined on the basis of the Heat Accumulation Storage Test.

SADT	20°C (68°F)
Emergency temperature (T_e)	10°C (50°F)
Control temperature (T_c)	0°C (32°F)
Method	The Heat Accumulation Storage Test is a recognized test method for the determination of the SADT of organic peroxides (see Recommendations on the Transport of Dangerous Goods, Manual of Tests and Criteria - United Nations, New York and Geneva).

Storage

Due to the relatively unstable nature of organic peroxides a loss of quality can be detected over a period of time. To minimize the loss of quality, Nouryon recommends a maximum storage temperature

Note	When stored under these recommended storage conditions, Trigonox® 23-C30 will remain within the Nouryon specifications for a period of at least three months after delivery.

Packaging and transport

The standard packaging is a 1000 l composite Intermediate Bulk Container (IBC). Delivery in a 20 m³ Nouryon tank container is also possible in a number of countries. Both packaging and transport meet the international regulations. For the availability of other packed quantities consult your Nouryon representative. Trigonox® 23-C30 is classified as Organic peroxide type F; liquid, temperature controlled, Division 5. 2; UN 3119.

Safety and handling

Keep containers tightly closed. Store and handle Trigonox® 23-C30 in a dry well-ventilated place away from sources of heat or ignition and direct sunlight. Never weigh out in the storage room. Avoid contact with reducing agents (e. g. amines), acids, alkalis and heavy metal compounds (e. g. accelerators, driers and metal soaps). Please refer to the Material Safety Data Sheet (MSDS) for further information on the safe storage, use and handling of Trigonox® 23-C30.
