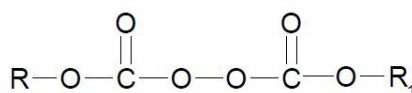


# Trigonox ADC-NS30

Isopropyl sec-butyl peroxydicarbonate



R, R<sub>1</sub> : isopropyl or sec-butyl

Initiator (30% active ingredient in diethylene glycol di(allyl carbonate)) for (co)polymerization of diethylene glycol di(allyl carbonate) based optical monomers.

## Applications

Trigonox® ADC-NS30 can be used for the polymerization of diethylene glycol di(allyl carbonate) based optical monomers. The use level of Trigonox® ADC-NS30 will depend on the particular cure parameters being used. Approximately 9. 5-10. 5% Trigonox® ADC-NS30 is required.

## Half-life data

The reactivity of an organic peroxide is usually given by its half-life (t<sub>1/2</sub>) at various temperatures. For Trigonox® ADC-NS30 in chlorobenzene half-life at other temperatures can be calculated by using the equations and constants mentioned below:

0.1 hr	at 80°C (176°F)
1 hr	at 62°C (144°F)
10 hr	at 45°C (113°F)
Formula 1	$k_d = A e^{-E_a/RT}$
Formula 2	$t_{1/2} = (\ln 2)/k_d$
E <sub>a</sub>	125.61 kJ/mole
A	7.69E+15 s <sup>-1</sup>
R	8.3142 J/mole·K

## Thermal stability

Organic peroxides are thermally unstable substances, which may undergo self-accelerating decomposition. The lowest temperature at which self-accelerating decomposition of a substance in the original packaging may occur is the Self-Accelerating Decomposition Temperature (SADT). The SADT is determined on the basis of the Heat Accumulation Storage Test.

SADT	0°C (32°F)
Emergency temperature (T <sub>e</sub> )	-10°C (14°F)
Control temperature (T <sub>c</sub> )	-20°C (-4°F)
Method	The Heat Accumulation Storage Test is a recognized test method for the determination of the SADT of organic peroxides (see Recommendations on the Transport of Dangerous Goods, Manual of Tests and Criteria - United Nations, New York and Geneva).

## Storage

Due to the relatively unstable nature of organic peroxides a loss of quality can be detected over a period of time. To minimize the loss of quality, Nouryon recommends a maximum storage temperature (T<sub>s</sub> max. ) for each organic peroxide.

Note	When stored under these recommended storage conditions, Trigonox® ADC-NS30 will remain within the Nouryon specifications for a period of at least 3 months after delivery.

## Packaging and transport

Trigonox® ADC-NS30 is packed in a 30 liter HDPE can (Nouryainer®) for 25 kg peroxide solution. Both packaging and transport meet the international regulations. For the availability of other packed quantities contact your Nouryon representative. Trigonox® ADC-NS30 is classified as Organic peroxide type D; liquid, temperature controlled; Division 5. 2; UN 3115; PG II.

## Safety and handling

Keep away from open fire, sparks and other sources of heat or ignition. Avoid contact with reducing agents (e. g. amines), acids, alkalis and heavy metal compounds (e. g. accelerators, driers and metal soaps).
