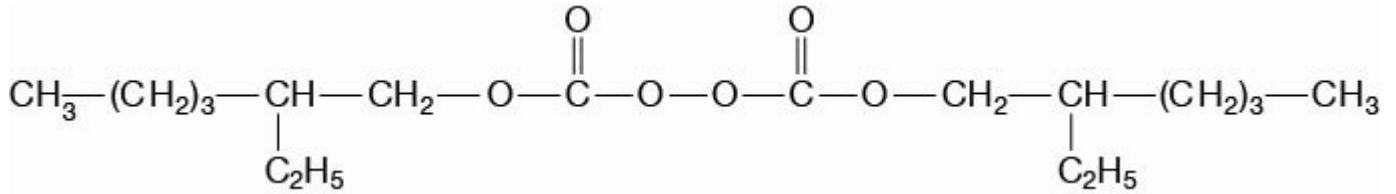


# Trigonox EHP-CH75

Di(2-ethylhexyl) peroxydicarbonate, 75% solution in odorless mineral spirits



Trigonox EHP-CH75 is an initiator (75% active ingredient in odorless mineral spirits) for (co)polymerization of ethylene, vinyl chloride and vinylidene chloride.

## Applications

Trigonox EHP-CH75 is an efficient initiator for the production of Low Density Polyethylene (LDPE). It is used both for tubular and autoclave processes. In most cases a combination with other peroxides is used to ensure a broad reactivity range. Trigonox EHP-CH75 is applied as an initiator for the suspension and mass polymerization of vinyl chloride in the temperature range between 40°C and 65°C.

## Half-life data

The reactivity of an organic peroxide is usually given by its half-life ( $t^{1/2}$ ) at various temperatures. For Trigonox EHP-CH75 in chlorobenzene:

0.1 hr	at 83°C (181°F)
1 hr	at 64°C (147°F)
10 hr	at 47°C (117°F)

## Thermal stability

Organic peroxides are thermally unstable substances, which may undergo self-accelerating decomposition. The lowest temperature at which self-accelerating decomposition of a substance in the original packaging may occur is the Self-Accelerating Decomposition Temperature (SADT). The SADT is determined on the basis of the Heat Accumulation Storage Test.

SADT	5°C (41°F)
Emergency temperature ( $T_e$ )	-5°C (23°F)
Control temperature ( $T_c$ )	-15°C ( 5°F)
Method	The Heat Accumulation Storage Test is a recognized test method for the determination of the SADT of organic peroxides (see Recommendations on the Transport of Dangerous Goods, Manual of Tests and Criteria - United Nations, New York and Geneva).

## Storage

Due to the relatively unstable nature of organic peroxides a loss of quality can be detected over a period of time. To minimize the loss of quality, Nouryon recommends a maximum storage temperature ( $T_s$  max.) for each organic peroxide product.

Ts Max.	-15°C ( 5°F)
Ts Min.	-25°C (-13°F)
Note	When stored under these recommended storage conditions, Trigonox EHP-CH75 will remain within the Nouryon specifications for a period of at least 3 months after delivery.

## Packaging and transport

Trigonox EHP-CH75 is packed in non-returnable, one gallon polyethylene containers of 7 lb net weight (4 per case). Both packaging and transport meet the international regulations. For the availability of other packed quantities consult your Nouryon representative. Trigonox EHP-CH75 is classified as Organic peroxide type D; liquid, temperature controlled; Division 5.2; UN 3115.

## Safety and handling

Keep containers tightly closed. Store and handle Trigonox EHP-CH75 in a dry well-ventilated place away from sources of heat or ignition and direct sunlight. Never weigh out in the storage room. Avoid contact with reducing agents (e.g. amines), acids, alkalis and heavy metal compounds (e.g. accelerators, driers and metal soaps). Please refer to the Safety Data Sheet (SDS) for further information on the safe storage, use and handling of Trigonox EHP-CH75.
